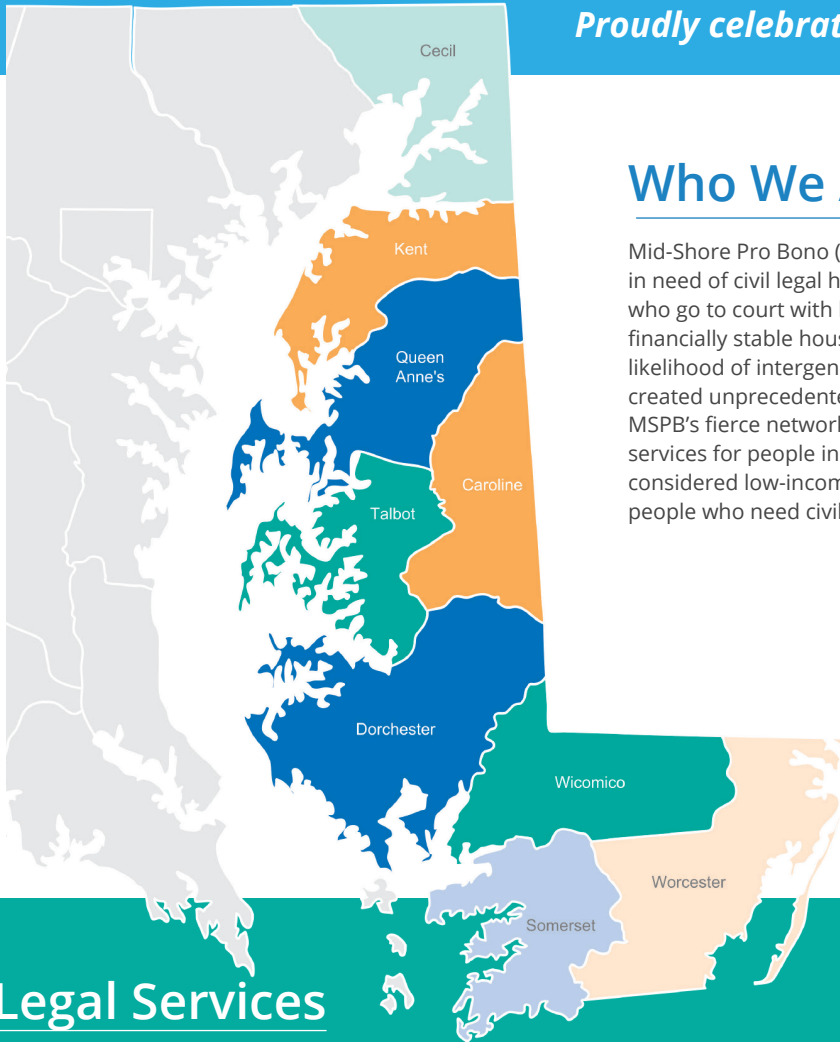

Who We Are and How We Help:

Mid-Shore Pro Bono (MSPB's) mission is to connect low income individuals, and families in need of civil legal help, with volunteer attorneys and community resources. People who go to court with legal representation get better outcomes, resulting in more financially stable households, safe and healthy homes for children, and a higher likelihood of intergenerational transfer of wealth. Even though the COVID-19 pandemic created unprecedented financial and legal challenges for everyone in our community, MSPB's fierce network of volunteer attorneys never stopped providing quality legal services for people in need. On the Eastern Shore, more than 50% of households are considered low-income, and more than 14% of families live in poverty. Over 80% of all people who need civil legal help in Maryland cannot afford it.

MSPB provides free access to legal services for those most in need in our community. We strive to pair qualified families and individuals with volunteer attorneys and believe that regardless of income or circumstance, everyone deserves equal access to civil justice. A Year Like No Other

Mid-Shore Pro Bono is still grappling with the effects of Covid -19, navigating our way through these turbulent times. First and foremost, we send our well wishes to you, your loved ones and your community. As we reflect on the year that has been so hard on all of us, we want to especially thank our staff, partners, board members, attorneys, interns and volunteers. Your support throughout this challenging year allowed MSPB to provide access to legal services for those most in need on the Eastern Shore. MSPB is truly grateful to be able to continue our work breaking down the barriers to equal access to civil justice for all.

Fiscal year 2020 began with restructure of Mid-Shore Pro Bono as we

entered into a new chapter of our organization. We expanded our Executive Team, welcoming a Managing Attorney, Meredith Girard and a Deputy Director, Michele Devine to our ranks. With merely more than 6 months under our belts after the restructuring, we were pleased to have found our stride and even added a new bilingual intake specialist to our staff. Then in the blink of an eye, the world as we knew it changed. Covid 19 dealt us all a swift blow changing the way we live and work. As so many organizations and service providers did, we quickly pivoted to the uncharted world of remote work, outfitting our staff with the equipment, technology, training, and support to ensure that we were able to continue to support our clients with uninterrupted continuity of service.


A Year Like No Other (continued)


As this global pandemic began to wreak havoc on the lives of so many of our neighbors, our mission remained steady and only furthered our desire to provide the much needed civil legal services that our low income neighbors so desperately needed. The first challenge was to ensure our Eastern Shore neighbors knew that we were still open and how to reach us. We contracted the design of a new multilingual website to better serve our clients remotely and aggressively expanded our community outreach. We increased our social media presence, partnered with food distribution sites, places of worship and our social service provider partners to distribute flyers. Constant monitoring of government local, state and federal government and court orders


became a priority in order to relay the ever changing regulations and requirements to our clients.


It soon became evident that Covid was not only exacerbating already existing civil legal services but creating new ones resulting in an increased demand for our services. Our network of volunteer lawyers provided free legal services on elder law, family law, landlord/tenant, mortgage foreclosure, consumer debt, and immigration. MSPB continued to help develop strategies and solutions to assist our clients and improve the financial and housing stability for Eastern Shore families.


Community Impact


 **\$1,972,750**
MSPB's volunteer attorneys provided 7,771 hours of legal services worth \$1,972,750 (based on the average hourly rate of \$250).

 **10,055**
MSPB received 10,055 volunteer hours from our attorneys.

 **86**
MSPB attorneys assisted 86 clients with immigration-related legal issues.

 **1,890**
MSPB provided 1,890 people with direct representation from a volunteer attorney.

 **226**
MSPB assisted 226 families with housing issues, including eviction and foreclosure prevention.

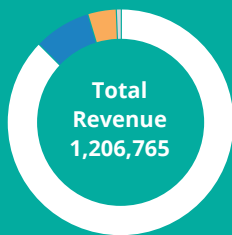
 **\$589,270**

MSPB responded to 2,821 calls for help.

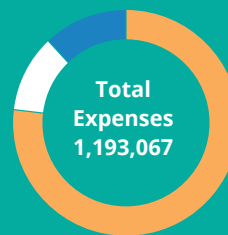
